

**PRIZE COMPETITION TERMS AND CONDITIONS**

**BOOK AND WIN**

**Name of organizer**

**Article 1.**

The Organizer of prize competition is CROATIA YACHTING t.o., Supilova 26 a, 21 000 Split, Croatia, ID code: HR-AB-21-170100068889, TEL: 00385 (0)21 332 332, FAX: 00385 (0) 21 332 331

**Purpose of organizing prize competition**

**Article 2.**

The present prize competition is organized with the purpose of promoting and upgrading the sale and the services of the organizer of the game by Internet.

**Duration of prize competition**

**Article 3.**

Prize competition shall be held from 01.11.2009 – 31.03.2010.

**Prize money**

**Article 4.**

The right to participate in a prize competition have all clients that confirm booking on Croatia yachting fleet who are natural persons and who accept these rules (hereinafter referred to as participant)

In order to participate in prize competition it is necessary, during the duration of the prize game, to book an accommodation on Croatia yachting fleet. It is also necessary to properly and completely fill out the prize coupon.

All participants shall, after the first payment of the charter fee, receive by e-mail the confirmation of participation and contract number.

The employees of the organizer of the prize competition as well as their families are not allowed to participate in the prize game or win a prize.

### **Value of prize**

#### **Article 5.**

The prize fund is determined by the following specification:

5 monthly prizes in the amount of 220 EURO

1 sailing holiday in the amount of 2 000 EURO

Total value of prize fund is 3 100 EURO

Prizes may not be converted to money or transferred to the third party. The prize cannot be reimbursed in cash and can be used for charter contracts that will be concluded for season 2010 under the condition that remaining un paid amount of the charter fee is equivalent or higher of the given prize amount. If the remaining un paid amount of the charter fee is less than the prize or if the charter fee is already paid, the participant can use his prize in the season 2011.

#### **Article 6.**

Drawing of the winners shall be held in the office of the organizer of the prize competition, Supilova 26 A, split

The drawing of the monthly prizes shall be held on the following dates: 08-12-2009, 08-01-2010, 08-02-2010, 08-03-2010, 08-04-2010

The drawing of the winner of the main prize shall be held on 08-04-2010.

The monthly winner is drawn from the base of all participants who have completed the first payment for the charter fee during the month in question.

All clients who have completed the first payment for the charter fee till the end of the duration of the prize competition, participate in the main prize drawing.

Every winner will be notified by an e-mail of the received prize, his name will also be published on the official web page of the organizer of the prize competition.

The prize winner is obligated to contact the organizer within 5 days of notification, by phone or e-mail, and confirm accepting the prize.

The prize winner who didn't confirm the acceptance of the prize within 5 days period loses the rights to prize.

### **Termination of prize competition**

#### **Article 7.**

Prize competition may be terminated only in the event of circumstances out of Organizer's responsibility and out of its control. Participants shall be informed about the termination of prize competition on web site of the Organizer.

### **Other provisions**

#### **Article 8.**

The participant in prize competition accepts all rights and obligations herein. In the event that the contest include fewer participants than the number of awards that are provided in the prize fund, the organizer will assign as many awards as a prize competition included participants.

#### **Article 9.**

The Municipal Court in Split shall be competent in the event of conflict between the Organizer and the participants in prize competition.

#### **Article 10.**

The present Rules shall take effect on the day of their publishing, and they shall become effective following the consent of the Ministry of Finance and the publication on the web page.

#### **Article 11.**

The organizer of the prize competition bears all costs of organization of the prize competition.
